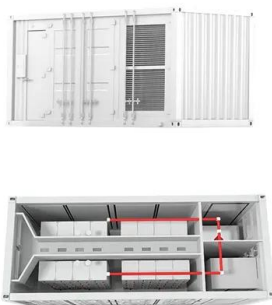
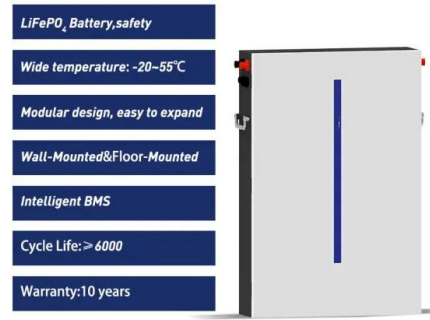

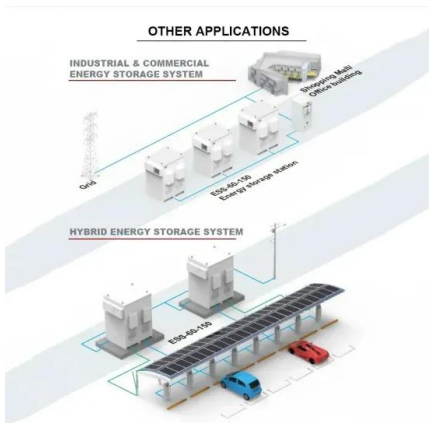


## Energy Storage Tax Incentive and Deployment Act of 2021
