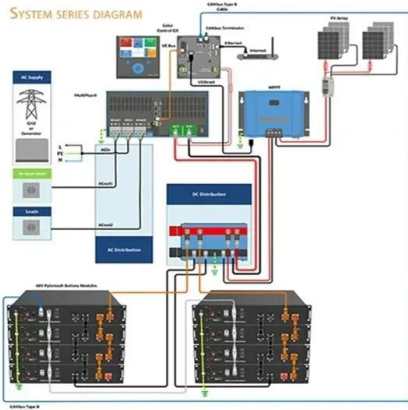
What is the difference between manufacturing and deployment of energy storage systems?

Manufacturing: Projects that manufacture energy storage systems for a variety of residential, commercial, and utility scale clean energy storage end uses. **Deployment:** Projects that deploy residential, commercial, and utility scale energy storage systems for a variety of clean energy and clean transportation end uses.

Why do we need energy storage technologies?

From providing critical backup power during natural disasters to supporting more renewable energy coming online, energy storage technologies make the grid more flexible and resilient. 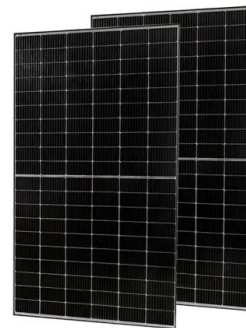
