Thailand energy storage project subsidy announcement



Overview

The Thai government is preparing a series of tax incentives to promote a low-carbon economy and encourage green investments, as announced by Finance Minister Pichai Chunhavajira at the Bangkok Post Conference 2024. Does Thailand need a battery energy storage system?

Thailand may lack the Battery Energy Storage Systems (BESS) necessary to navigate supply and demand challenges. The 2024 PDP draft included 10,000 MW of BESS, but this may see the country struggle to fulfil carbon neutrality and Net Zero commitments over the coming decades.

How many Bess projects were approved in Thailand in 2022?

In 2022, the Thai government approved 24 BESS projects, all of which were located alongside solar operations. Their total combined storage capacity was 994 MW. Interestingly, this allowed generators to sign semi-firm power purchase agreements (PPAs) with the Electricity Generating Authority of Thailand (EGAT) with minimum availability guarantees.

Why is battery storage a problem in Thailand?

This is partly due to a lack of clarity on how battery storage fits into existing electricity infrastructure. In 2022, the Thai government approved 24 BESS projects, all of which were located alongside solar operations. Their total combined storage capacity was 994 MW.

How will Thailand reach the 2024 PDP goal?

The 2024 PDP draft provided a more detailed breakdown of how Thailand will reach this goal. During the plan's lifespan, 47,251 MW of new electricity will be sourced with 34,851 MW coming from renewables. Top 3 renewable energy sources in Thailand PDP 2024: 1) Solar (24,412 MW) 2) Wind (5,345 MW) 3) Floating solar (2,681 MW)

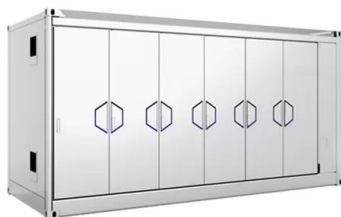
